

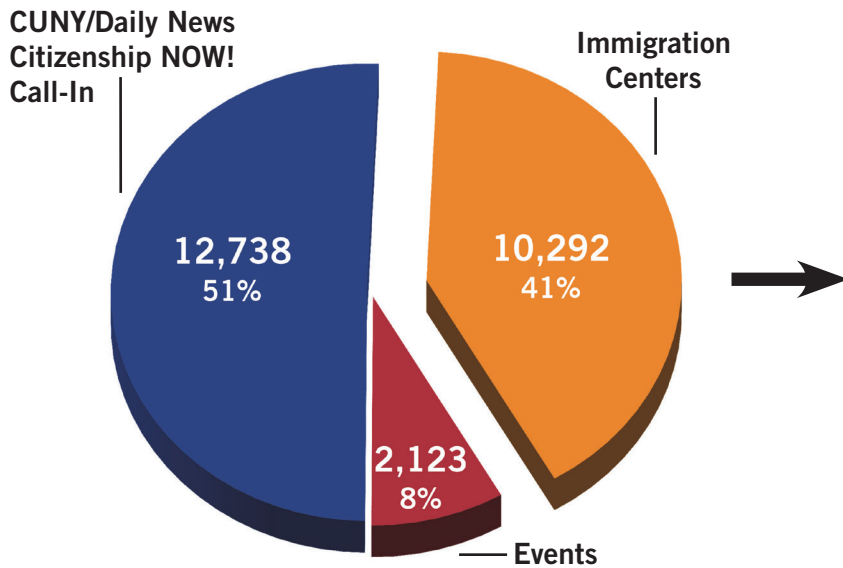

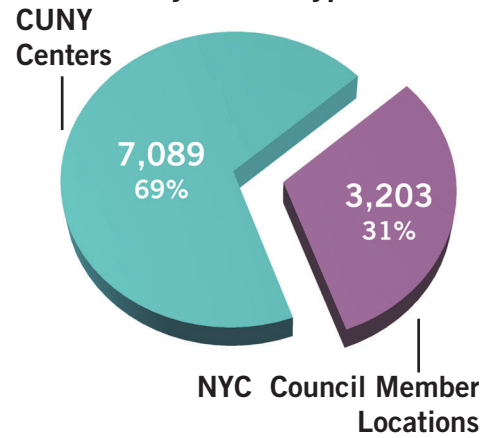

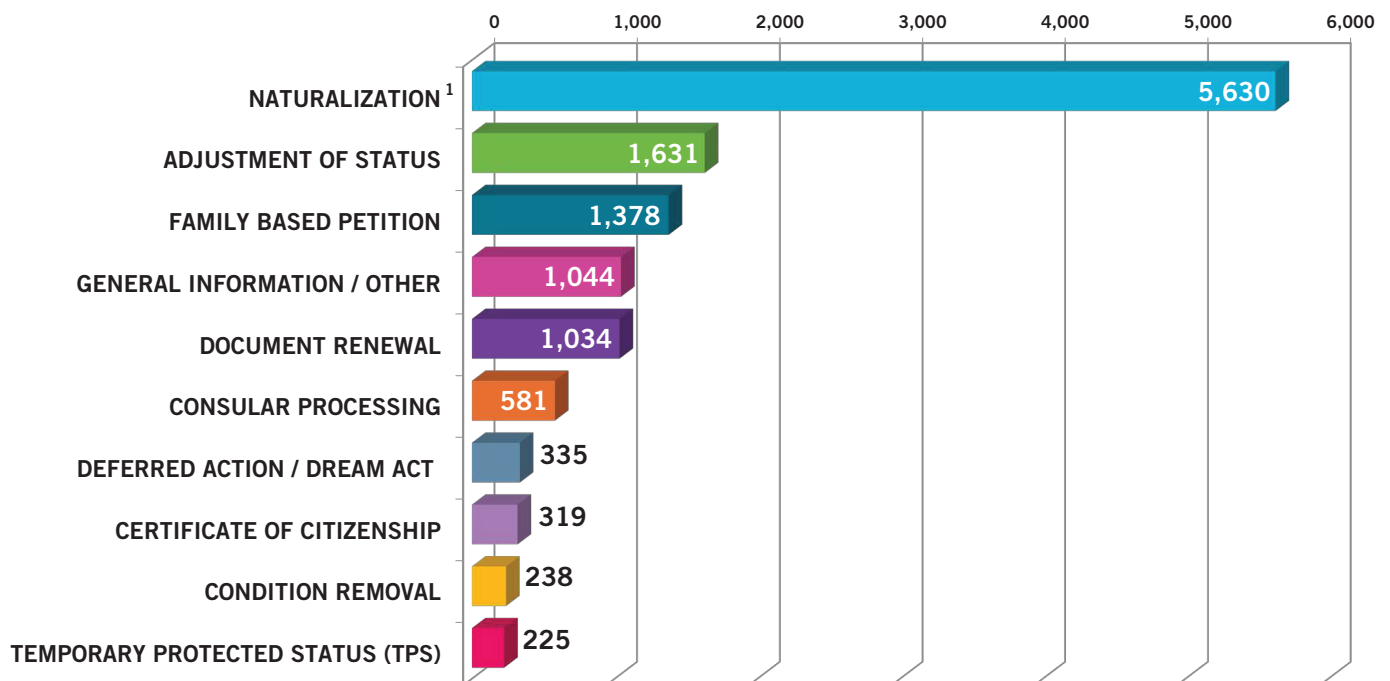
## In The Last Fiscal Year We...

- Helped **3,512** people with U.S. Citizenship (Naturalization Applications and Certificates of Citizenship)
- Assisted **1,690** people in their efforts to unite with their families (Family-Based Petitions, Adjustment of Status, Consular Processing and Removal of Conditions on Legal Permanent Resident Status)
- Assisted **560** people with humanitarian immigration benefits and human rights issues [Temporary Protected Status (TPS), Deferred Action for Childhood Arrivals (DACA) and consultations on DREAM Act]

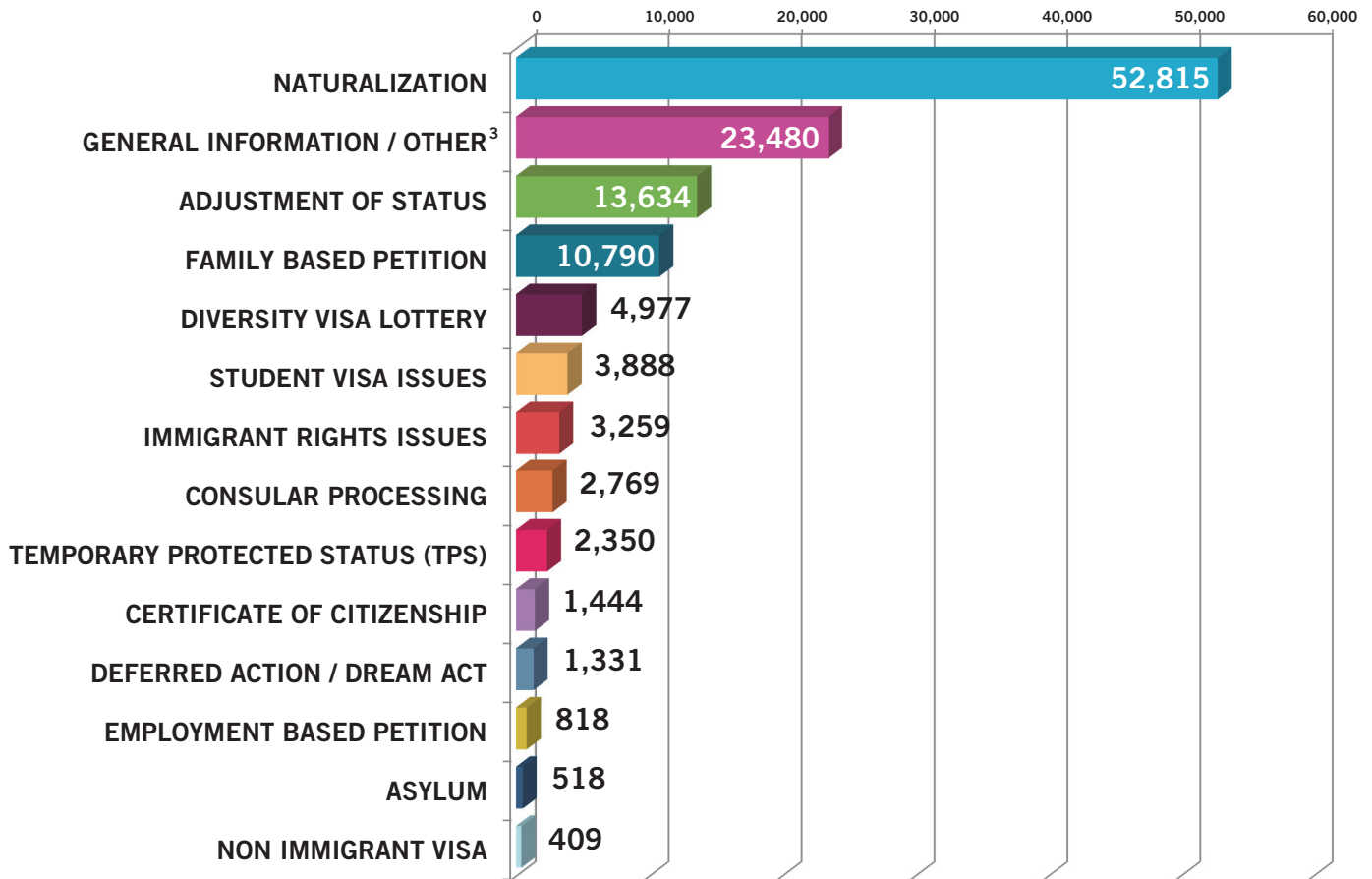
